CURRICULUM VITAE – PHILIP HAYDEN, Ed.D.

SUMMARY

During his 26 years as an Agent with the Federal Bureau of Investigation (FBI), Dr. Philip Hayden, while serving in the FBI's Chicago and New York offices, was involved in criminal investigations, organized crime, and foreign counterintelligence. In addition to serving as a Special Agent in those offices, he became a program manager and tactical instructor at the FBI Academy in Quantico, Virginia. Dr. Hayden was involved in writing dozens of lesson plans and assisted in developing the SWAT manual and tactical lesson plans. In addition, he provided hands-on training to his fellow FBI Special Agents in the SWAT program, Violent Crimes Task Forces, and new and senior agents' training. He led training courses and developed curricula to prepare thousands of federal agents, military, and police officers worldwide on specific FBI techniques and procedures in order to help them better prepare to perform in a more efficient and safe manner. Dr. Hayden, as the lead instructor, provided training to over 6,000 federal, state, city, and local police officers throughout the United States and an additional 4,000 police officers worldwide on several concepts, to include the principles of arrest techniques, use of force, firearms, planning concepts, felony vehicle stops, high-risk entries, and investigative techniques. This training incorporated the concept and tactics for dealing with life-threatening issues that impact safety and survival. This program, which was designed, developed, and implemented by Dr. Hayden, is called the Law Enforcement Training for Safety and Survival (LETSS). Twenty years later, it is still being taught within the FBI.

With a Doctorate in Education, Dr. Hayden has built upon his extensive education and experience to become a consultant and court-certified expert witness, providing testimony in federal, state, county, and district courts in criminal and civil cases for both plaintiff and defense matters. Areas in which he has testified include: Use of Force; Appropriateness of Law Enforcement Training; High-Risk Arrest Procedures; Use of Electronic Control Devices; SWAT and Sniper Utilization; Tactical Training; Firearms; Rappelling; and the Tactical and Survival Mindset. He also served as a keynote and motivational speaker for a variety of groups while still a Special Agent in the FBI and later as a law enforcement consultant.

Dr. Hayden was featured in a made-for-TV documentary on the survival mindset for police officers, *Inside the FBI: Surviving the Street*, Printz Production, distributed by Chevron Publishing.
